The reduction in the marginal tax rate for C corporations to 21 percent (down from 35 percent), the reduction in individual tax rates, and the retention of special low tax rates on qualified dividends substantially reduce the combined amount of taxes on qualified dividends relative to that on the same amount of compensation. Single or married taxpayers are not allowed to deduct more than \$10,000 of property taxes and state and local income or sales taxes. Some states are considering repealing their income taxes and replacing them with employer-side payroll taxes. Taxes imposed on a business (such as employer payroll taxes) are still deductible under federal law. A business can just write them off their corporate income tax (or individual tax, if the business is a pass-through entity). This would not only totally offset the new limit on deducting state income taxes - it would amount to a sizable tax cut for many middle-class families.
