As Richard J. Evans explains, it was largely because the town was a "free city" within Germany that was governed by the "English" ideals of laissez-faire. The absence of an effective public-health policy combined with ill-founded medical theories and the miserable living conditions of the poor to create a scene ripe for tragedy. The story of the "cholera years" is, in Richard Evans's hands, tragically revealing of the age's social inequalities and governmental pitilessness and incompetence; it also offers disquieting parallels with the world's public-health landscape today, including the current coronavirus crisis.

Martyn Lyons re-assesses European history between the fall of Napoleon and the Crimean War. Refusing to characterize the period as a "Restoration." Lyons presents the struggle of the European

monarchies for credibility in the wake of conflicts which had shattered the mystique of kingship. Lyons stresses the invented aspects of emerging nationalism, as well as the important process of rebuilding a political culture after 1815, and the democratic Revolutions of 1848. The three intervening decades between the Congress of Vienna and the Revolutions of 1848 are marked by enormous social, political, economic and cultural change. Liberalism, nationalism, romanticism and industrialism profoundly affected the course of Europe and compelled conservative monarchies to accept the principles of collective action and military force to curb political revolution. In the years immediately following 1815, the Quadruple and Holy Alliances served the dual purpose of preventing a restoration of Bonapartism and suppressing revolutions. By the 1820s these international associations dissipated, but the principles upon which they were founded informed the decisions of the respective governments through 1848. The classic articles and papers collected in this volume attempt to illustrate that despite the substantial changes to European society which occurred during these thirty years, European powers accepted common principles which influenced their state's domestic and foreign

policies.

Dr Berg argues that technical change was one of the foremost theoretical concerns of Ricardo and his successors, and the foundation for their distinctly optimistic view of the future. The development of Europe accelerated from the middle of the 17th century with the formation of the nation states and the growth of empires. By the beginning of the 20th century, European empires dominated most of the world's surface - however, the two

A wave of revolutionary ideals, the collapse of Napoleon's imperial dreams and the changes wrought by the Restoration all contributed to the birth in Europe of new models of social behaviour accompanied by a taste in art something other than the

empire style with its echoes of the classical period. Attention turned instead to the intimate, domestic sphere, to the everyday events in the world of the middle class and to a sentimental and slightly melancholic vision of nature. In Central Europe and especially Austria, Bohemia, Hungary and northern Germany, this milieu came to be defined as "Biedermeier". More than an artistic style, Biedermeier was a way of life which had a profound influence on all the arts in Europe from 1815 to 1848--although with distinct regional variations, for example, in Russia, Scandinavia, France of Charles X and Louis Philippe, Italy of Carlo Alberto of Savoy and in Victorian England. It was especially influential in the areas of furniture design and the decorative arts. This book, with its up-to-date critical and historical reading of Biedermeier, offers an extraordinarily rich repertoire of paintings, glassware, ceramics, textiles and jewellery. It also includes an annotated bibliography providing an overview of the Biedermeier phenomenon, a phenomenon which stands at the root of an emerging middle-class culture in Europe as well as of international modernism.

unprecedented way. This print revolution led to a series of real and bloody revolutions in the streets of European cities. The revolutionaries of 1848 had the temerity to imagine universal human rights and a world in which everyone could live without fear, hunger, or humiliation. If looked at like this, the events of 1848 do not seem such 'poor incidents', as Marx described them, nor such an embarrassing failure after all. Returning to 1848, we can choose to look back on that 'springtime of the peoples' as a moment of tragi-comic failure, obliterated by the brutalities that followed, or we can look again, and see it as a proleptic moment of stored potential, an extraordinary series of events that generated long-distance and sustainable ideas about global citizenship, international co-operation, and a shared and common humanity which have not yet been fully understood or realised.
