This book presents new research results on the challenges of local politics in different European countries, including Germany, the Netherlands, the Nordic countries and Switzerland,

together with theoretical considerations on the further development and strengthening of local selfgovernment. It focuses on analyses of the most recent developments in local democracy and administration. Building on hundreds of thousands of systematically collected and content-coded local policy agenda observations, this book examines - theoretically and empirically - the policy agenda effects of four central aspects of any political system: the institutions that structure

politics; the problems confronting the political system: the occurrence of regular and free elections; and the actors navigating the political system.
