The former slave gets into the eye of the Caribbean hurricane during the French Revolution in 1794. He fights in Napoleonic Wars and get English Pow. He returns back to Guadeloupe after his release and takes part in the rebellion of the Bataillon des Antilles in May 1802 when slavery was to be reintroduced by the order of Napoleon. The unit is expelled from the island. François is ordered to serve in Mantua, where he escapes and finds refuge in the Danish duchy of Holstein. He settles there and founds a family in October 1806. François is a direct ancestor of the author. His biography is retraced. The conditions of slave trade are analyzed for Nigeria, the trade itself as are society and culture in Guadeloupe. Which are the factors leading to the rebellion of May 1802? How Guadeloupe deals with it and the reintroduction of slavery? The deportation of the soldiers causes an international crisis. Which policy does Napoleon lead referring to people of color? What happens in the unit of Black Pioneers in Mantua? François is literally fighting for freedom and a humble decent life, free of the construct of slavery. He finds his freedom in the Danish duchy of Holstein. The book contributes a micro-historic view to the macro-history.

In 1861, a young slave named Sam escapes to search for his father, who has been conscripted into the Confederate Army, and makes his way to a northern city, while back at the Virginia plantation where Sam was raised, Annabelle, the owner's daughter, struggles to run things after her father's death. Simultaneous. In San Francisco, CA, in 1858, a young African American man was freed from the claims of a white man who sought to return him to slavery in Mississippi. This was one year after the Supreme Court's notorious Dred Scott decision and during the California Gold Rush, which saw the population of the state rise from 7,000 to more than 60,000 in a few short years. Archy Lee was the name of the man who, with the aid of anti-slavery lawyers and determined opponents of human bondage, had just won his freedom from the claims of Charles Stovall. With the aid of pro-slavery lawyers and equally determined supporters, Stovall had sought to capture him and carry him back to a far-away slave plantation. Yet the book is not solely about Archy Lee. It is also about the travel routes that the gold-seekers followed to California in the 1850s, some by land over the Great Plains, some by sea around Cape Horn, yet others by sailing from the east coast of North America to the isthmus of Panama, where they crossed over the land there by train and continued on by sea to San Francisco. It is about the efforts of the racially motivated lawmakers to suppress the rights of all of California's residents except whites, and to subject people of African, Asian, Hispanic, and Native American descent to second-, third-, or even fourth-class citizenship. It is about the residents of the state—including many whites—who fought back against those efforts, seeking to ameliorate or repeal the discriminatory laws and introduce a measure of fairness and justice into California's civil life. It is about the lawyers and judges who participated in Archy Lee's legal struggles in 1858, some supporting his claims for freedom while others ferociously opposed them and, in the process, elevated their own political and professional profiles.

Thomas Bynum carefully examines the activism of the NAACP youth and effectively refutes the perception of the NAACP as working strictly through the courts. His research illuminates the many direct-action activities undertaken by the young people of the NAACP—activities that helped precipitate the breakdown of racial discrimination and segregation in America. He also explores the evolution of the youth councils and college chapters, including their sometime rocky relationship with the national office, and captures the successes, failures, and challenges the NAACP youth groups experiences at the national, state, and local levels. This latest edition in Triangle Square's For Young People series is a gripping account of the summer that changed America. In the summer of 1964, as the Civil Rights movement boiled over, the Student Nonviolent Coordinating Committee (SNCC) sent more than seven hundred college students to Mississippi to help black Americans already battling for democracy, their dignity and the right to vote. The campaign was called "Freedom Summer." But on the evening after volunteers arrived, three young civil rights workers went missing, presumed victims of the Ku Klux Klan. The disappearance focused America's attention on Mississippi. In the days and weeks that followed, volunteers and local black activists faced intimidation, threats, and violence from white people who didn't believe African Americans should have the right to vote. As the summer unfolded, volunteers were arrested or beaten. Black churches were burned. More Americans came to Mississippi, including doctors, clergymen, and Martin Luther King. A few frightened volunteers went home, but the rest stayed on in Mississippi, teaching in Freedom Schools, registering voters, and living with black people as equals. Freedom Summer brought out the best and the worst in America. The story told within these pages is of everyday people fighting for freedom, a fight that continues today. Freedom Summer for Young People is a riveting account of a decisive moment in American history, sure to move and inspire readers.

The fate of poor and working-class African Americans—who are unquestionably represented among neoliberalism’s victims—is inextricably linked to that of other poor and working-class Americans Reed contends that the road to a more just society for African Americans and everyone else is obstructed, in part, by a discourse that equates entrepreneurialism with freedom and independence. This, ultimately, insists on divorcing race and class. It tells how a gallant Missourian, true to sacred ties of friendship, gave time and thought and means, long and cheerfully, to securing the release of the Youngers from prison.—taken from preface

In the late 1850s, at a time when many men and women spoke out against slavery, few had the same impact as John Brown, the infamous white abolitionist who backed his beliefs with unstoppable action.

The author of this book, Fred Arthur MacKenzie (1869-1931), was a correspondent active in the early 20th century. For several years he worked with the Daily Mail as a traveling correspondent in the Far East. one of the few Western correspondents that wrote about the Korean resistance against Japan during the Japanese Rule. To create this account of the war, MacKenzie had to escape into the interior of the Korean opposition, although it was extremely dangerous.
