The thesis of this book is that only a social personalism and no form of impersonalism can adequately account for the solidarity and stability of what we individuals share with all other members of our society, our second nature. In the ancient world

The central problem was to find the basis on which individuals formed societies and how they could do so. Buford's question is with a more basic issue: 'What do individuals and society share in
