Genomics is the study of the genomes of organisms. The field includes intensive efforts to determine the entire DNA sequence of organisms and fine-scale genetic mapping efforts. It is a discipline in genetics that applies recombinant DNA, DNA sequencing methods, and bioinformatics to sequence, assemble, and analyze the function and structure of genomes. *Genomics I - Humans, Animals and Plants* is the first volume of our *Genomics* series. Chapter 1 describes the development of a unique nascent DNA enrichment peak detection algorithm which utilizes Savitzky-Golay convolution kernel smoothing at different base-pair resolutions.
