The purpose of this three-year long multiple qualitative case study was to explore and gain an in-depth understanding of the process of collaborative teaching as an alternative method of instruction in higher education. It was my intention to identify distinct stages of the process and depict issues involved in it. The collaborations were conducted by three teams of faculty members teaching in a major research university.

This book addresses concerns about the hampering impact of the short-term orientation of investors in capital markets on corporate governance. May brought to the research task both a familiarity with the broad issues of federal disaster policy-having recently completed a book (May, 1985) about disaster relief policy

Our greatest debt is to those federal and state officials who took time from their busy schedules to offer their implementation perspectives about emergency management.
