Behavior analysis, a rapidly growing profession, began with the use and application of conditioning and learning techniques to modify the behavior of children or adults presenting severe management problems, often because of developmental disabilities. Especially since their practice often involves aversive stimuli or punishment, they confront many special ethical challenges.
