Over six days during the spring break of 1936 at the University of Michigan, a twenty-year-old college sophomore wrote his first play, NO VILLAIN. His aim was to win the prestigious Avery Hopwood award and, more importantly, the \$250 prize he needed in order to return to college the following year. Miller won the award, but the play would remain buried until it received its world premiere nearly eighty years after it was written. NO VILLAIN tells the story of a garment industry strike that sets a son against his factory proprietor father. Here, Miller explores the Marxist theory that would see him hauled before the House Un-American Activities Committee years later. THE STORY: Angela, a hard-bitten call-girl, is visited by Tom, a private detective of long acquaintance, who is convinced that she can supply information about a murder case which, some years earlier, resulted in a miscarriage of justice. As Tom plays on their former closeness, trying to draw out the facts he seeks, Angela withdraws behind a schizophrenic screen of multiple personalities ranging from a shrinking violet called Emily, to a haughty English-woman named Renata. Doggedly persistent, Tom does, in the end, break through the fears which have driven Angela to hide the truth within herself. With chilling intensity she pours through a tale of duplicity and corruption and recounts how an innocent man ended up paying for the crimes of others. As the play ends Tom offers to drive Angela to her home, but she ends up, at the same time, disturbed by the knowledge that his worst fears have been borne out.

Whereas recent research has demonstrated how disinterested social validation may skew valuation in meritocratic domains, interested promotion may be at least as important a factor. As suggested by research on reputational entrepreneurship, a producer's death shifts promotion opportunities in two respects. First, it prevents the producer (or "salesman") from engaging in promotional activity to step up their promotional activity on behalf of the deceased. Analysis of the impact made by the premature death of 720 elite life scientists on the citation trajectories of their articles indicates that death results in a long-lasting, positive increase in citation rates, relative to the trajectories for equivalent articles by counterfactual, still-living scientists. This effect seems due largely to the media's attention to recognition efforts on behalf of the still-living scientists, and is strongest for articles that had received relatively little attention prior to the death, as well as those authored by stars who died at a relatively young age. The upshot is clear evidence of informational inefficiency, which derives from the challenges of absorbing the massive volume of scientific knowledge produced. Scientists' identities are valued in part because of their scientific valuations, despite ostensible norms that enjoin the scientific community to divorce the researcher's identity from her work.

Arthur Miller's penultimate play, Resurrection Blues, is a darkly comic satirical allegory that poses the question: What would happen if Christ were to appear in the world today? In an unidentified Latin American country, General Felix Barriaux has captured an elusive revolutionary leader. The rebel, known by various names, is rumored to have performed miracles throughout the countryside. The General plans to crucify the mysterious man, and the exclusive television rights to the twenty-four-hour reality-TV event have been sold to an American network for \$25 million. An allegory that asserts the interconnectedness of our actions and each person's culpability in world events, Resurrection Blues is a comedic and tragic satire of precarious morals in our media-saturated age.

Willy Loman returns home exhausted after a cancelled business trip. Willy complains to Linda that their son, Biff, has yet to make good on his life. Despite Biff's promising showing as an athlete in high school, he flunked senior-year math and never went to college. Biff and his brother Happy, who is temporarily staying with Willy and Linda after Biff's unexpected return from the West, reminisce about their childhood together. They discuss their father's mental degeneration, which they have witnessed in the form of his constant indecisiveness and daydreaming about the boys' high school years. Willy walks in, angry that the two boys have never amounted to anything. In an effort to pacify their father, Biff and Happy tell their father that Biff plans to make a business proposition the next day. Death of a Salesman is a 1949 play written by American playwright Arthur Miller. It was the recipient of the 1949 Pulitzer Prize for Drama and Tony Award for Best Play. The play premiered on Broadway in February 1949, running for 742 performances, and has been revived on Broadway four times, winning three Tony Awards for Best Revival. It is widely considered to be one of the greatest plays of the 20th century.
