Moving across the Great Lakes to Chicago leads to the Illinois River into the Mississippi. The entire length of that mighty River then is cruised and described. Other tributary rivers explored town-by-city-by-town are the St. Croix, Ohio, Muskingum, Kentucky, Green, Kanawha, Allegheny, Monongahela, and Arkansas, most to their head of navigation.
