From the Preface: This manual, Child Protective Services: A Guide for Caseworkers, examines the roles and responsibilities of child protective services (CPS) workers, who are at the forefront of every community's child protection efforts. The manual describes the basic stages of the CPS process and the steps necessary to accomplish each stage: intake, initial assessment or investigation, family assessment, case planning, service provision, evaluation of family progress, and case closure. Best practices and critical issues in casework practice are underscored throughout. The primary audience for this manual includes CPS caseworkers, supervisors, and administrators. State and local CPS agency trainers may use the manual for preservice or inservice training of CPS caseworkers, while schools of social work may add it to class reading lists to orient students to the field of child protection. In addition, other professionals and concerned community members may consult the manual for a greater understanding of the child protection process. This manual builds on the information presented in A Coordinated Response to Child Abuse and Neglect: The Foundation for Practice. We are taken deep into Belichick's tactical mind, odd work habits, and strained relationships, including his sincere but unspoken love for the players and a near fistfight with a former assistant coach. It is an illuminating depiction of a mastermind, and an organization, dedicated not only to winning but to breaking a league designed to prevent the emergence of a single, unbeatable team. Yet it is in Wickersham's portrait of Brady—from his childhood in northern California to his challenging years at the University of Michigan to his astonishing early superstardom in the NFL—that the source of the Patriots' sheer endurance comes into focus. Even as he navigated an improbable rise to fame, Brady was driven by a totalizing ambition to be great, not as an endpoint, but as an ever-unfolding process. Sustaining greatness, however, came with a price. Wickersham reveals, to an extent no other journalist has, the clashes among the coach, the quarterback, and the owner, Robert Kraft—conflicts that resulted in the team's best performances but also, eventually, the dissolution of the dynasty itself.
