The text began as a set of lecture notes for the discrete mathematics course at the University of Northern Colorado. This course serves both as an introduction to topics in discrete math and as the "introduction to proof" course for math majors. The course is usually taught with a large amount of student inquiry, and this text is written to help facilitate this. Four main topics are covered: counting, sequences, logic, and graph theory. Along the way proofs are introduced, including proofs by contradiction, proofs by induction, and combinatorial proofs. The book contains over 470 exercises, including 275 with solutions and over 100 with hints. There are also Investigate! activities throughout the text to support active, inquiry based learning. The "Bibliography" list refers only to the books used by the authors during the preparation of the exercisebook. Clearly, it mentions only a fraction of available books in graph theory. The invention of the authors was also driven by numerous journal articles, which are impossible to list here. Algorithmic Graph Theory and Perfect Graphs provides an introduction to graph theory through practical problems. This book presents the mathematical and algorithmic properties of special classes of perfect graphs. Organized into 12 chapters, this book begins with an overview of the graph theoretic notions and the algorithmic design. This text then examines the complexity analysis of computer algorithm and explains the differences between computability and computational complexity. Other chapters consider the parameters and properties of a perfect graph and explore the class of perfect graphs known as comparability graph or transitively orientable graphs. This book discusses as well the two characterizations of triangulated graphs, one algorithmic and the other graph theoretic. The final chapter deals with the method of performing Gaussian elimination on a sparse matrix wherein an arbitrary choice of pivots may result in the filling of some zero positions with nonzeros. The Mathematics Education of Teachers, published by The Conference Board on the Mathematical Sciences, recommends 21 semester hours of mathematics for prospective teachers of middle-grades mathematics. In several states pre-service teachers preparing to teach middle-grades mathematics and pre-service teachers preparing to teach elementary school must complete 6- 9 semester hours of mathematics content at the junior-senior level. Linear algebra is a living, active branch of mathematics which is central to almost all other areas of mathematics, both pure and applied, as well as computer science, the physical and social sciences, and engineering. It entails an extensive corpus of theoretical results as well as a large body of computational techniques. The book is intended to be used in one of several possible ways: (1) as a self-study guide; (2) as a textbook for a course in advanced linear algebra, either at the upper-class undergraduate level or at the first-year graduate level; or (3) as a reference book. It is also designed to prepare a student for the linear algebra portion of prelim exams or PhD qualifying exams. The volume is self-contained to the extent that it does not assume any previous formal knowledge of linear algebra, though the reader is assumed to have been exposed, at least informally, to some basic ideas and techniques, such as the solution of a small system of linear equations over the real numbers. More importantly, it does assume a seriousness of purpose and a modicum of mathematical sophistication. The book also contains over 1000 exercises, many of which are very challenging.

This updated introduction to modern numerical analysis is a complete revision of a classic text originally written in Fortran but now featuring the programming language C++. It focuses on a relatively small number of basic concepts and techniques. Many exercises appear throughout the text, most with solutions. An extensive tutorial explains how to solve problems with C++.

subjects as operational research, chemistry, sociology and genetics. I. The topics of this book The concept of a matroid has been known for more than five decades. Whitney (1935) introduced it as a common generalization of graphs and matricies. It has become clear how important the concept is, for the following reasons: (1) Combinatorics (or discrete mathematics) was considered by many to be a collection of interesting, so-called ideas. However, like other branches of mathematics, combinatorics also encompasses some general tools that can be learned and then applied, to various problems. Matroid theory is one such tool. Within combinatorics, the relative importance of algorithms has increased with the spread of computers. Classical analysis did not even consider problems where "only" a finite number of solutions were studied. Now such problems are not only considered, but their complexity is often analyzed in considerable detail. Some questions of this type (for example, the determination of whether an algorithm is optimal) cannot even be answered without matroidal tools.
