Wyoming's Notary Laws are found in Wyoming Statutes 32-1-101 through 32-1-114 and in Wyoming Statutes 34-26-101 through 34-26-304. A change in the Notary Statutes effective July 1, 2014 increased the maximum fee that may be charged by notarial officers. The question/answer format of this handbook reflects common kinds of issues which notaries public may encounter. The answers to these questions have been reproduced from other states' handbooks and from published notary authorities. They are intended only as "best practices" or basic guidance to notaries.
