one year might be dangerous heresy the next. The first martyrs were Catholics, who cleaved to Rome in defiance of Henry VIII's break with the papacy. But with the accession of Henry's daughter Mary - soon to be nicknamed 'Bloody Mary' - the charge of heresy was leveled against devout Protestants, who chose to burn rather than recant. At the center of Virginia Rounding's vivid account of this extraordinary period are two very different characters. The first is Richard Rich, Thomas Cromwell's protégé, who, almost uniquely, remained in a position of great power, influence and wealth under three Tudor monarchs, and who helped send many devout men and women to their deaths. The second is John Deane, Rector of St Bartholomew's, who was able, somehow, to navigate the treacherous waters of changing dogma and help others to survive. The Burning Time is their story, but it is also the story of the hundreds of men and women who were put to the fire for their faith.

Henry VIII remains the most iconic and controversial of all English Kings. For over four-hundred years he has been lauded, reviled and mocked, but rarely ignored. In his many guises - model Renaissance prince, Defender of the Faith, rapacious plunderer of the Church, obese Bluebeard-- he has featured in numerous works of fact and fiction, in books, magazines, paintings, theatre, film and television. Yet despite this perennial fascination with Henry the man and monarch, there has been little comprehensive exploration of his historiographic legacy. Therefore scholars will welcome this collection, which provides a systematic survey of Henry's reputation from his own age through to the present. Divided into three sections, the volume begins with an examination of Henry's reputation in the period between his death and the outbreak of the English Civil War, a time that was to create many of the tropes that would dominate his historical legacy. The second section deals with the further evolution of his reputation, from the Restoration to Edwardian era, a time when Catholic commentators and women writers began moving into the mainstream of English print culture. The final section covers the twentieth and twenty-first centuries, which witnessed an explosion of representations of Henry, both in print and on screen. Taken together these studies, by a distinguished group of international scholars, offer a lively and engaging overview of how Henry's reputation has been used, abused and manipulated in both academia and popular culture since the sixteenth century. They provide intriguing insights into how he has been reinvented at different times to reflect the cultural, political and religious demands of the moment; sometimes as hero, sometimes as villain, but always as an unmistakable and iconic figure in the historical landscape.

England's first Protestant foreign policy venture took place under Henry VIII, who in the wake of the break with Rome pursued diplomatic contacts with the League of Schmalkalden, the German Protestant alliance. This venture was supported by evangelically-inclined counsellors such as Thomas Cromwell and Thomas Cranmer, while religiously conservative figures such as Cuthbert Tunstall, John Stokesley and Stephen Gardiner sought to limit such contacts. The king's own involvement reflected these opposed reactions: he was interested in the Germans as alliance partners and as a consultative source in establishing the theology of his own Church, but at the same time he was reluctant to accept all the religious innovations proposed by the Germans and their English advocates. This study breaks new ground in presenting religious ideology, rather than secular diplomacy, as the motivation behind Anglo-Schmalkaldic negotiations. Relations between England and the League exerted a considerable influence on the development of the king's theology in the second half of the reign, and hence affected the redirection of religious policy in 1538, the passing of the Act of Six Articles, the marriage of Henry to Anne of Cleves and the fall of Thomas Cromwell. The examination of the development of Henry's religious thinking is set in the wider context of the foreign policy imperatives of the German Protestants, the ministerial priorities of Thomas Cromwell and factional politics at the court of Henry VIII. The 'monster' displayed here is, at the very least, a newer type, more beset by anxieties and insecurities, and more tightly surrounded by those who equated loyalty with fear, self-interest and blind obedience. This ground-breaking book also demonstrates that Henry VIII's priorities were always primarily martial rather than marital, and accepts neither the necessity of his all-consuming quest for a male heir nor his need ultimately to sever ties with Rome. As the story unfolds, Henry's predicaments prove largely of his own making, the paths he chooses neither the only nor the best available. For Henry VIII was not only a bad man, but also a bad ruler who failed to achieve his aims and blighted the reigns of his two immediate successors. Five hundred years after he ascended the throne, the reputation of England's best known king is being rehabilitated and subtly sanitized. Yet Tudor historian John Matusiak paints a colourful and absorbingly intimate portrait of a man wholly unfit for

power.

This book presents a new edition of the classic study of the religious changes that transformed England in the sixteenth century. Henry VIII officially brought the Protestant Reformation to England in the 1530s when he severed the English Church from the Papacy. But the seeds of the movement, according to A.G.Dickens, were planted much earlier. The English Reformation, first published in 1964, follows the movement from its late medieval origins through the settlement of Elizabeth I in 1559 and the rise of Puritanism.

Abandoning the traditional narrative approach to its subject, this book presents an analytical account which aims to reflect the logic of the conditions, events, and policies of Henry's brief Reformation. It starts with the fundamental question of the royal supremacy, and goes on to investigate its application to the ecclesiastical establishment of England and to the traditional religion of the people. It then considers the initial formation of a vernacular and literate religious culture, and concludes by examining the emergence of religious division in Henry's reign.

During the last decade of Henry VIII's life, his Protestant subjects struggled to reconcile two loyalties: to their Gospel and to their king. This book tells the story of that struggle and describes how a radicalised English Protestantism emerged from it. Focusing on the critical but neglected period 1539–47, Dr Ryrie argues that these years were not the 'conservative reaction' of conventional historiography, but a time of political fluidity and ambiguity. Most evangelicals continued to hope that the king would favour their cause, and remained doctrinally moderate and politically conformist. The author examines this moderate reformism in a range of settings - in the book trade, in the universities, at court and in underground congregations. He also describes its gradual eclipse, as shifting royal policy and the dynamics of the evangelical movement itself pushed reformers towards the more radical, confrontational Protestantism which was to shape the English identity for centuries.
