Given considerations are calcium and phosphorus in blood, skeletal calcium and phosphorus, and the factors affecting adsorption. A discussion also focuses on trace elements and the effects of protein, carbohydrates, fats, and vitamins in nutrition. Nomograms for infusion therapy measures, blood loss evaluation and calculating red blood cell transfusion amount were proposed; 3. Nomograms were built on the background of interfering relationship of blood hematocrit and hemoglobin concentration; 4. New guidelines for infusion therapy, blood loss evaluation and calculating transfusion amount for proper hematocrit increase were proposed; 5. New method for early verification of occult bleeding has been suggested. Three major homeostatic blood states were described: (1) target state, (2) state of maximal isoosmotic plasma dilution and (3) dehydration. Target states maintain optimal red cell mass and blood volume correlation. Other two maintain critical plasma hydration origin deviations from target state. Three new nomograms enable planning and evaluation of infusion therapy and red cell mass transfusion, quantitate evaluation of blood loss and early detection of occult bleeding based on the dynamics of blood hematocrit and hemoglobin concentration.
