Proactive policing, as a strategic approach used by police agencies to prevent crime, is a relatively new phenomenon in the United States. It developed from a crisis in confidence in policing that began to emerge in the 1960s because of social unrest, rising crime rates, and growing skepticism regarding the effectiveness of standard approaches to policing. In response, beginning in the 1980s and 1990s, innovative police practices and policies that took a more proactive approach began to develop. This report uses the term "proactive policing" to refer to all policing strategies that have as one of their goals the prevention or reduction of crime and disorder and that are not reactive in terms of focusing primarily on uncovering ongoing crime or on investigating or responding to crimes once they have occurred. Proactive policing is distinguished from the everyday decisions of police officers to be proactive in specific situations and instead refers to a strategic decision by police agencies to use proactive police responses in a programmatic way to reduce crime. Today, proactive policing strategies are used widely in the United States. They are not isolated programs used by a select group of agencies but rather a set of ideas that have spread across the landscape of policing. *Proactive Policing* reviews the evidence and discusses the data and methodological gaps on: (1) the effects of different forms of proactive policing on crime; (2) whether they are applied in a discriminatory manner; (3) whether they are being used in a legal fashion; and (4) community reaction. This report offers a comprehensive evaluation of proactive policing that includes not only its crime prevention impacts but also its broader implications for justice and U.S. communities.

The often-tenuous relationship between law enforcement and communities of color, namely African Americans, has grown increasingly strained, and the call for justice has once again ignited the demand for criminal justice reform. Rebuilding the trust between the police and the citizens that they have sworn to protect and serve requires that criminal justice practitioners and educators collaborate with elected officials and commit to an open, ongoing dialogue on the most challenging issues that remain unresolved but demand collective attention and support. Reform measures are not limited to policing policies and practices, but rather extend throughout the criminal justice system. There is no denying that the criminal justice system as we know it is flawed, but not beyond repair. *Global Perspectives on Reforming the Criminal Justice System* provides in-depth and current research about the criminal justice system around the world, its many inadequacies, and why it urgently needs reformation. Offering a fully fleshed outline of the current system, this book details the newest research and is incredibly important to fully understand the flaws of

the criminal justice system across the globe. The goals of this book are to improve and advance the criminal justice system by addressing the glaring weaknesses within the system and discuss potential reforms including decreasing the prison population (decarceration) and improving police/community relations. This insightful book examines the allegations against the professionalism, transparency, and integrity of law enforcement toward minority groups, from a global perspective. It addresses the challenges inherent in maintaining strong ties with members of the community, and draws attention to obstacles in ensuring public confidence and trust in rule of law institutions. Most importantly, the book provides insight into mechanisms and proposals for policy reform that would permit enhanced police-community partnership, collaboration and mutual respect. Acknowledging the consistency of this concern despite geographic location, ethnic diversity, and religious tolerance, this book considers controversial factors that have caused many groups and individuals to question their relationship with law enforcement. The book examines the context of police-community relations with contributed research from Nigeria, South Africa, Kosovo, Turkey, New Zealand, Mexico, Scandinavia and other North American and European viewpoints. It evaluates the roles that critical factors such as ethnicity, political instability, conflict, colonization, mental health, police practice, religion, critical criminology, socialism, and many other important aspects and concepts have played on perceptions of policing and rule of law. A valuable resource for law enforcement practitioners and researchers, policy makers, and students of criminal justice, *Policing and Minority Communities: Contemporary Issues and Global Perspectives* confronts crucial challenges and controversies in policing today with quantitative and qualitative research and practical policy recommendations.

This edited collection is concerned with the ideas, challenges, demands and framework of conditions behind police education from an international perspective. Whilst not directly concerned with a classical comparison of education concepts from different countries, the broad range of international contributors consider issues such as professionalization programmes, how higher education programmes influence police organizations, as well how higher education influences police practice in a global context. Examining a wide array of countries from Germany to China and Brazil to show the flawed nature of an education system based purely upon an approach concerned with police officer numbers, the editors of this book argue for the need for greater scientific education among police around the world to meet contemporary developments. A timely and well-informed study, this book meets a crucial gap in the literature and will serve as an important contribution to existing work on policing, crime prevention, and

theoretical criminology.

This book critically investigates Nordic criminal justice as a global role model. This book begins with a broader discussion of cybercrime and attacks targeting ATMs and then focuses on a specific type of cybercrime named “ATM Hacking.” It discusses ATM Hacking from a more full scope of aspects, including technology, modus operandi, law enforcement, socio-economic and geopolitical context, and theory development. After unpacking a classic case of ATM Hacking and its modus operandi, implications for cybersecurity and prevention, intra- and inter-agency collaboration, and theory development are presented. This book also demonstrates the analysis of extensive qualitative data collected from a high-profile case in which European criminal group hacked into a London voice mail server belonging to a Taiwanese financial institution – First Commercial Bank,. Then it programmed dozens of ATMs to “spit out” millions of dollars of cash. The successful crackdown on this type of crime is rare, if not unique, while the number of similar crimes has increased enormously in recent years and the trend seem to continue unabatingly. Further, the implications go beyond a country or a continent. Intra- and inter-agency collaboration among players of law enforcement is essential to the case especially in the police context of “turf jealousies.” The authors seek to document the ways in which agencies collaborate, as well as the perceived benefits and challenges of cooperation. Whether the broader political and contextual climates in which these agencies operate, limit the extent to which they can cooperate. This book is useful as a reference for researchers and professionals working in the area of cybercrime and cybersecurity. University professors can also use this book as a case study for senior seminars or graduate courses.

Whereas most of the literature on the subject is written from a Western viewpoint, this unique volume examines empirical research, policies, and practices from Asian and African countries, as well as those from Europe, the Americas, and Australia, to provide a truly global perspective. Divided into three parts, the book first examines theories and research on cross-national differences in stalking among college students, ex-partner stalking in Finland, cyberstalking victimization in Singapore, the heterogeneity of stalking and stalkers in Australia, public familiarity and understanding of stalking/harassing legislation in Australia, the United Kingdom, and the United States, and more. The book's second part focuses on national portraits of stalking in a number of understudied populations, including Lithuania, Spain, Denmark, Portugal, and South Africa. Finally in the third section of the book, the chapters largely emphasize policy and best practice, including the Dutch model of policing stalking, risk assessment and management of stalking in Sweden, psycho-legal responses to online interpersonal harm, the German approach to stopping stalking, the United Kingdom response to assessing and managing stalking, and the work of the Danish Stalking Centre. Securing Development: Public Finance and the Security Sector highlights the role of public finance in the delivery of security and criminal justice services. This book offers a framework for analyzing public financial management, financial transparency, and oversight, as well as expenditure policy issues that determine how to most appropriately manage security and justice services. The interplay among security, justice, and public finance is still a relatively unexplored area of development. Such a perspective can help security actors provide more professional, effective, and efficient security and justice services for citizens, while also strengthening systems for accountability. The book is the result of a project undertaken jointly by staff from the World Bank and the United Nations, integrating the disciplines where each institution holds a comparative advantage and a core mandate. The primary audience includes government officials bearing both security and financial responsibilities, staff of international organizations working on public expenditure management and security sector issues, academics, and development practitioners working in an advisory capacity.

Contemporary police service delivery and performance are complex phenomena.
