 Compilers and operating systems constitute the basic interfaces between a programmer and the machine for which he is developing software. In this book we are concerned with the construction of the former. Our intent is to provide the reader with a firm theoretical basis for compiler construction and sound engineering principles for selecting alternate methods, implementing them, and integrating them into a reliable, economically viable product. The emphasis is upon a clean decomposition employing modules that can be re-used for many compilers, separation of concerns to facilitate team programming, and flexibility to accommodate hardware and system constraints. A reader should be able to understand the questions he must ask when designing a compiler for language X on machine Y, what tradeoffs are possible, and what performance might be obtained. He should not feel that any part of the design rests on whim; each decision must be based upon specific, identifiable characteristics of the source and target languages or upon design goals of the compiler. Because learning to design programs is about the study of principles and the acquisition of transferable skills, the text does not use an off-the-shelf industrial language but presents a tailor-made teaching language. For the same reason, it offers DrRacket, a programming environment for novices that supports playful, feedback-oriented learning. The environment grows with readers as they master the material in the book until it supports a full-fledged language for the whole spectrum of programming tasks. This second edition has been completely revised. While the book continues to teach a systematic approach to program design, the second edition introduces different design recipes for interactive programs with graphical interfaces and batch programs. It also enriches its design recipes for functions with numerous new hints. Finally, the teaching languages and their IDE now come with support for images as plain values, testing, event-driven programming, and even distributed programming.

This book provides a gently paced introduction to techniques for implementing programming languages by means of compilers and interpreters, using the object-oriented programming language Java. The book aims to exemplify good software engineering principles at the same time as explaining the specific techniques needed to build compilers and interpreters.

The Formal Semantics of Programming Languages provides the basic mathematical techniques necessary for those who are beginning a study of the semantics and logics of programming languages. These techniques will allow students to invent, formalize, and justify rules with which to reason about a variety of programming languages. Although the treatment is elementary, several of the topics covered are drawn from recent research, including the vital area of concurrency. The book contains many exercises ranging from simple to miniprojects. Starting with basic set theory, structural operational semantics is introduced as a way to define the meaning of programming languages along with associated proof techniques. Denotational and axiomatic semantics are illustrated on a simple language of while-programs, and fall proofs are given of the equivalence of the operational and denotational semantics and soundness and relative completeness of the axiomatic semantics. A proof of Godel's incompleteness theorem, which emphasizes the impossibility of achieving a fully complete axiomatic semantics, is included. It is supported by an appendix providing an introduction to the theory of computability based on while-programs. Following a presentation of domain theory, the semantics and methods of proof for several functional languages are treated. The simplest language is that of recursion equations with both call-by-value and call-by-name evaluation. This work is extended to languages with higher and recursive types, including a treatment of the eager and lazy lambda-calculi. Throughout, the relationship between denotational and operational semantics is stressed, and the proofs of the correspondence between the operation and denotational semantics are provided. The treatment of recursive types - one of the more advanced parts of the book - relies on the use of information systems to represent domains. The book concludes with a chapter on parallel programming languages, accompanied by a discussion of methods for specifying and verifying nondeterministic and parallel programs.

Formal Syntax and Semantics of Programming Languages: A Laboratory Based Approach presents a panorama of techniques in formal syntax, operational semantics and formal semantics. Using a teaching/learning perspective rather than a research-oriented approach, an understanding of the meta-languages is accessible to anyone with a basic grounding in discrete mathematics and

programming language concepts. Throughout the book, valuable hands-on laboratory exercises provide the opportunity for practical application of difficult concepts. Various exercises and examples, implementing syntactic and semantic specifications on real systems, give students hands-on practice. This book remedies that situation by connecting theory, empirical research, and practical curricular suggestions on pragmatics for learners of different proficiency levels: It surveys the field comprehensively and, with useful tasks and activities, offers rich guidance for teaching and testing L2 pragmatics. Mainly referring to pragmatics of English and with relevant examples from multiple languages, it is an invaluable resource for practicing teachers, graduate students, and researchers in language pedagogy and assessment.

A comprehensive introduction to type systems and programming languages. A type system is a syntactic method for automatically checking the absence of certain erroneous behaviors by classifying program phrases according to the kinds of values they compute. The study of type systems—and of programming languages from a type-theoretic perspective—has important applications in software engineering, language design, high-performance compilers, and security. This text provides a comprehensive introduction both to type systems in computer science and to the basic theory of programming languages. The approach is pragmatic and operational; each new concept is motivated by programming examples and the more theoretical sections are driven by the needs of implementations. Each chapter is accompanied by numerous exercises and solutions, as well as a running implementation, available via the Web.

Dependencies between chapters are explicitly identified, allowing readers to choose a variety of paths through the material. The core topics include the untyped lambda-calculus, simple type systems, type reconstruction, universal and existential polymorphism, subtyping, bounded quantification, recursive types, kinds, and type operators. Extended case studies develop a variety of approaches to modeling the features of object-oriented languages.

This book identifies, defines and illustrates the fundamental concepts and engineering techniques relevant to applications of software languages in software development. It presents software languages primarily from a software engineering perspective, i.e., it addresses how to parse, analyze, transform, generate, format, and otherwise process software artifacts in different software languages, as they appear in software development. To this end, it covers a wide range of software languages – most notably programming languages, domain-specific languages, modeling languages, exchange formats, and specifically also language definition languages. Further, different languages are leveraged to illustrate software language engineering concepts and techniques. The functional programming language Haskell dominates the book, while the mainstream programming languages Python and Java are additionally used for illustration. By doing this, the book collects and organizes scattered knowledge from software language engineering, focusing on application areas such as software analysis (software reverse engineering), software transformation (software re-engineering), software composition (modularity), and domain-specific languages. It is designed as a textbook for independent study as well as for bachelor's (advanced level) or master's university courses in Computer Science. An additional website provides complementary material, for example, lecture slides and videos. This book is a valuable resource for anyone wanting to understand the fundamental concepts and important engineering principles underlying software languages, allowing them to acquire much of the operational intelligence needed for dealing with software languages in software development practice. This self-instructional manual on the interpretation and use of epidemiologic data deals with the basic concepts and skills needed for the appraisal of published reports or one's own findings. Applications in clinical medicine, public health, community medicine, and research are all taken into consideration. Making Sense of Data is designed as a workbook of short exercises and instructional self-tests that introduce fundamental approaches and procedures in data interpretation and develop competency in working with epidemiologic tools. Basic concepts are presented in the first section, which also demonstrates the step-by-step assessment of data. The next section discusses rates and other simple measures, and the third shows how to judge their accuracy. Section IV and V deal with more complex issues of associations between variables and the appraisal of cause-effect relationships. Section VI deals with meta-analysis (the critical review and integration of the findings from separate studies) and section VII with the questions to be asked before deciding to apply study results in practice. Numerous changes have been made in this edition, including the addition of a section on the practical application of epidemiological findings, discussions of new topics (Cox proportional hazards regression, qualitative studies, ROC curves), and fresh examples.
