Throughout, the authors highlight the fact that calculus provides a firm foundation to concepts and results that are generally encountered in high school and accepted on faith; for example, the classical result that the ratio of circumference to diameter is the same for all circles. A number of topics are treated here in considerable detail that may be inadequately covered in calculus courses and glossed over in real analysis courses.

**This is a book about prime numbers, congruences, secret messages, and elliptic curves that you can read cover to cover. It grew out of undergr-uate courses that the author taught at Harvard, UC San Diego, and the University of Washington. The systematic study of number theory was initiated around 300B. C. when Euclid proved that there are in7nitely many prime numbers, and also cleverly deduced the fundamental theorem of arithmetic, which asserts that every positive integer factors uniquely as a product of primes. Over a thousand years later (around 972A. D. ) Arab mathematicians formulated the congruent number problem that asks for a way to decide whether or not a given positive integer n is the area of a right triangle, all three of whose sides are rational numbers. Then another thousand years later (in 1976), Di7e and Hellman introduced the 7rst ever public-key cryptosystem, which enabled two people to communicate secretly over a public communications channel with no predetermined secret; this invention and the ones that followed it revolutionized the world of digital communication. In the 1980s and 1990s, elliptic curves revolutionized number theory, providing striking new insights into the congruent number problem, primality testing, publ- key cryptography, attacks on public-key systems, and playing a central role in Andrew Wiles' resolution of Fermat's Last Theorem.**

Calculus Gems, a collection of essays written about mathematicians and mathematics, is a spin-off of two appendices ("Biographical Notes" and "Variety of Additional Topics") found in Simmons' 1985 calculus book. With many additions and some minor adjustments, the material will now be available in a separate softcover volume. The text is suitable as a supplement for a calculus course and/or a history of mathematics course. The overall aim is bound up in the question, "What is mathematics for?" and in Simmons' answer, "To delight the mind and help us understand the instructor to pick and choose among them. Part A "Brief Lives", is a biographical history of mathematics from earliest times (Thales, 625-547 BC) through the late 19th century (Weierstrass, 1815-1897) that serves to connect mathematics to the broader intellectual and social history of Western civilization. Part B, "Memorable Mathematics", is a collection of interesting topics from number theory, geometry, and science arranged in an order roughly corresponding to the order of most calculus courses. Some of these sections have a few problems for the student to learn some mathematics not contained in the usual courses, and instructors can assign student papers and projects based on the essays. The book teaches by example that mathematics is more than computation. Original illustrations of influential mathematicians in history and their inventions accompany the brief biographies and mathematical discussions.

This book presents first-year calculus roughly in the order in which it was first discovered. The first two chapters show how the ancient calculations of practical problems led to infinite series, differential and integral calculus and to differential equations. The establishment of mathematical rigour for these subjects in the 19th century for one and several variables is treated in chapters III and IV. Many quotations are included to give the flavor of the history. The text is complemented by a large number of examples, calculations and mathematical pictures and by exercises for researchers.

Students studying different branches of computer graphics have to be familiar with geometry, matrices, vectors, rotation transforms, quaternions, curves and surfaces and as computer graphics software becomes increasingly sophisticated, calculus is also being used to resolve its associated problems. In this 2nd edition, the author extends the scope of the original book to include applications of calculus in the areas of arc-length parameterisation of curves, geometric continuity, tangent and normal vectors, and curvature. The author draws upon his experience in teaching mathematics to undergraduates to make calculus appear no more challenging than any other branch of mathematics. He introduces the subject by examining how functions depend upon their independent variables, and then derives the appropriate mathematical underpinning and definitions. This gives rise to a function 's derivative and its antiderivative, or integral. Using the idea of limits, the reader is introduced to derivatives and integrals of many common functions. Other chapters address higher-order derivatives, partial derivatives, jacobians, vector-based functions, single, double and triple integrals, with numerous worked examples, and over a hundred and seventy colour illustrations. This book complements the author 's other books on mathematics for computer graphics, and assumes that the reader is familiar with everyday algebra, trigonometry, vectors and determinants. After studying this book, the reader should understand calculus and its application within the world of computer graphics, games and animation.
