This is not to say that a fundamental understanding of structural behaviour is not presented or that only computer-based tech niques are given. Indeed, the reverse is true. Understanding structural behaviour is an underlying theme and many solution techniques suitable for hand computation, such as moment distribution, are retained. The most widely used method of computer-based structural analysis is the matrix stiffness method.
