When photographs documenting the torture and humiliation of prisoners at Abu Ghraib came to the attention of a horrified public, national and international voices were raised in shock, asking how this happened. This continuum has its roots in our public discussions of the war on terror and the metaphors through which they are repeatedly framed. On Easter Monday, 24 April 1916, the socialist writer James Connolly ordered an armed group to march down Dame Street in Dublin, in what became a citizens’ occupation of Dublin city centre. As Connolly hoped, the shockwave launched by the doomed uprising kindled fires of revolution throughout the colonies during all of the 20th century. On 18 November 2010, a small unescorted group of IMF technocrats walked down Dame Street – home of their goal, the Irish Central Bank – to articulate the re-colonisation of Ireland. Ireland: A Colony Once Again first explains the lack of public protest by the Irish in the face of a grim future. In particular, the author argues that the IMF move simply cemented in place a deal done long ago between globalized corporatism and Irish Catholic nationalism. Almost all sectors of Irish civil society that might have offered resistance, including Connolly’s Labour movement, had long ago been bought off or destroyed. However, the vacuum created by the perceived fall of the neoliberal world order in 2008 affords an opportunity to re-construct Ireland.

In particular, the author argues that the mechanisms used to buttress the current order – from the state security apparatus to the mainstream media – have a less firm hold on power than appears at first sight to be the case. Furthermore, given its history, culture and geographic location, Ireland is very well placed to re-imagine and re-invent itself in a short space of time, in freedom and joy.

This book examines a wide array of phenomena that arguably constitute the most noxious, extreme, terrifying, murderous, secretive, authoritarian, and/or anti-democratic aspects of national and international politics. Scholars should not ignore these “dark sides” of politics, however unpleasant they may be, since they influence the world in a multitude of harmful ways. The second volume in this two-volume collection focuses primarily on assorted religious extremists, including apocalyptic millenarian cults, Islamists, and jihadist terrorist networks, as well as CBRN (chemical, biological, and nuclear) terrorism and the supposedly new “nexus” between organized criminal and extremist groups employing terrorist operational techniques. A range of global case studies are included, most of which focus on the lesser known activities of certain religious extremist milieus. This collection should prove to be essential reading for students and researchers interested in understanding seemingly arcane but nonetheless important dimensions of recent historical and contemporary politics.

Globalised neo-liberalism has produced multiple crises – social, ecological, political. In the past, crises of global order have generated large-scale social transformations, and the current crises likewise hold a transformative promise. Social movements become a crucial barometer, in signalling both the demise and rise of political formations and programs. Elite strategies, framed as crisis management, create their own disordering side-effects. Experiments in movement strategy gain greater significance, as do contending elite efforts at repressing, managing or displacing the fall-out. In this book we investigate both movements and management in the face of crisis, taking crisis and unanticipated consequences as a normal state-of-play. The book enquires into the winners and losers from crisis, and investigates the movement-management nexus as it unfolds in particular localities as well as in broader contexts. The book deals with some of the most pressing conflicts of our time, and produces a range of theoretical insights:

the ubiquity of crisis is seen as not only a hallmark of social life, but a way into a different kind of social analysis. This book was published as a special issue of Globalizations.

This text provides a balanced analysis of geopolitics and geoeconomics and their interrelationship. Its presentation combines a theoretical approach with both historical and contemporary perspectives in order to comprehensively depict the evolution of the global political economy. The author critically examines the interdependent relations among industrialized countries as well as the dependent relations between industrialized and less developed countries.
