It covers the case law until October 2008, insofar as English translations were available.

In an era of the rise of the free market and economic globalization, Martin Cloonan examines why politicians and policymakers in the UK have sought to intervene in popular music - a field that has often been held up as the epitome of the free market form. Cloonan traces the development of government attitudes and policies towards popular music from the 1950s to the present, discovering the prominence of two overlapping concerns: public order and the political economy of music. Since the music industry began to lobby politicians, particularly on the issue of copyright in relation to the internet, an inherent tension has become apparent with economic rationale on one side, and Romantic notions of 'the artist' on the other. Cloonan examines the development of policy under New Labour; numerous reports which have charted the economics of the industry; the New Deal for Musicians scheme and the impact of devolution on music policy in Scotland. He makes the case for the inherently political nature of popular music and asserts that the development of popular music policies can only be understood in the context of an increasingly close working relationship between government and the cultural industries. In addition he argues that a rather myopic view of the music industries has meant that policy initiatives have lacked cohesion and have generally served the interests of multinational corporations rather than struggling musicians.

This 15-hour free course explored the relationship between social work practice and the law that regulates social work in Scotland.

The law had as much influence on our ancestors as it does on us today, and it occupies an extraordinary range of individuals, from eminent judges and barristers to clerks and minor officials. Yet, despite burgeoning interest in all aspects of history and ancestry, lawyers and legal history have rarely been looked at from the point of view of a family historian. And this is main purpose of Stephen Wades accessible and authoritative introduction to the subject. Assuming that the reader has little prior knowledge of how or where to look for such information, he traces the evolution of the law and the legal professions. He describes the parts played in the system by solicitors, officers of the High Court, registrars, recorders, town clerks, clerks of the peace, proctors, coroners, notaries, parliamentary agents, judges, barristers and magistrates. Also he identifies the various archives, records and books that the family researcher can turn to, and discusses other sources including the internet. Stephen Wades concise account of legal history and research resources will be an invaluable guide for anyone who is studying the subject or seeking an ancestor who was associated with it.

In answering these questions, the book analyses policing in Scotland in the context of the new and emerging ideas about the nature, purposes and methods of policing that are developing elsewhere in the world, and seeks to determine how far Scottish policing is maintaining its own traditions, or simply becoming a localised example of wider global trends. The second edition of this popular text introduces new chapters on crime investigation, police unionism, ethnic minorities, policing violence and forensic science, as well as incorporating a major new theme which seeks to explain how those responsible for policing Scotland set about dealing with current issues such as terrorism and organised crime. This book makes a significant contribution to the current debate on policing in Scotland, and as such is an essential text for academics and those interested in policing issues.

In recent decades there has been increasing historical interest in various aspects of local urban politics, resulting in a much better understanding of the recruitment and socio-economic characteristics of municipal leadership and the exercise of power at a local level. However, much less is known about the highly important offices and office-holders standing at the ceremonial, political and executive head of towns and cities. Through a comparative analysis of mayoralty since 1800, this volume explores the characteristics of the office in relation to such issues as the constitutional position of mayors, their ceremonial and executive roles, their representational status in relation to local, regional and central authority, and their public visibility, which at various times has been used to highlight or blur issues of race, gender, politics or religion within a community. Drawing on examples from contrasting national contexts in Eastern and Western Europe, and North America, and with contributions from both historians and political scientists, this book will be welcomed as an important step in providing a much fuller international picture of the development and nature of urban governance.

While migrants categorised as illegal immigrants are generally voiceless, various representations of these migrants are disseminated into Irish society through the Parliament and newsprint media. This book examines how those two institutions discursively represented illegal immigration in Ireland during the 2000s. Those negative discourses function to maintain the nationstate rationale of governance, practices of inequality and exclusion, and legitimized expressions of racism. For the first time since 1601, a number of leading common law nations have almost simultaneously chosen to revise and place on the statute books the law relating to charity. The Politics of Charity examines the reasons for this and for the varying legislative outcomes. This book examines the legal framework and political significance of charity, as developed within England & Wales, contrasts this with the experiences of other common law nations and explores the resulting implications for government/sector relationships in those countries. It suggests that charity law lies at the heart of the relationship between government and the non profit sector, that there is an unmistakable political agenda driving charity law reform and that the differential in legislative outcomes reflects important differences in the policies pursued by the governments concerned. Looking at fundamentally different approaches of government towards the sector in the UK, Ireland, the US, New Zealand, Canada, Singapore and Australia, O'Halloran argues the results will have implications for the present workings of parliamentary democracy. The book brings together a collection of leading international experts to explore, through a comparative analysis, the lessons learnt through implementation and the future directions of crime prevention policies.

In Violence Risk, Chris Webster and Steve Hucker discuss the accuracy of prediction and highlight how violence assessments would improve if well-established findings became entrenched in clinical and research practice.
