

Uct Math Olympiads Past Papers

This problem book is ideal for high-school and college students in search of practice problems with detailed solutions. All of the standard introductory topics in mechanics are covered: kinematics, Newton's laws, energy, momentum, angular momentum, oscillations, gravity, and fictitious forces. The introduction to each chapter provides an overview of the relevant concepts. Students can then warm up with a series of multiple-choice questions before diving into the free-response problems which constitute the bulk of the book. The first few problems in each chapter are derivations of key results/theorems that are useful when solving other problems. While the book is calculus-based, it can also easily be used in algebra-based courses. The problems that require calculus (only a sixth of the total number) are listed in an appendix, allowing students to steer clear of those if they wish. Additional details: (1) Features 150 multiple-choice questions and nearly 250 free-response problems, all with detailed solutions. (2) Includes 350 figures to help students visualize important concepts. (3) Builds on solutions by frequently including extensions/variations and additional remarks. (4) Begins with a chapter devoted to problem-solving strategies in physics. (5) A valuable supplement to the assigned textbook in any introductory mechanics course.

This book is the fruit of a symposium in honor of Ted Eisenberg concerning the growing divide between the mathematics community and the mathematics education community, a divide that is clearly unhealthy for both. The work confronts this disturbing gap by considering the nature of the relationship between mathematics education and mathematics, and by examining areas of commonality as well as disagreement. It seeks to provide insight into the mutual benefit both stand to gain by building bridges based on the natural bonds between them.

This book reports recent major advances in automated reasoning in geometry. The authors have developed a method and implemented a computer program which, for the first time, produces short and readable proofs for hundreds of geometry theorems. The book begins with chapters introducing the method at an elementary level, which are accessible to high school students; latter chapters concentrate on the main theme: the algorithms and computer implementation of the method. This book brings researchers in artificial intelligence, computer science and mathematics to a new research frontier of automated geometry reasoning. In addition, it can be used as a supplementary geometry textbook for students, teachers and geometers. By presenting a systematic way of proving geometry theorems, it makes the learning and teaching of geometry easier and may change the way of geometry education.

Among the many beautiful and nontrivial theorems in geometry found in Geometry Revisited are the theorems of Ceva, Menelaus, Pappus, Desargues, Pascal, and Brianchon. A nice proof is given of Morley's remarkable theorem on angle trisectors. The transformational point of view is emphasized: reflections, rotations, translations, similarities, inversions, and affine and projective transformations. Many fascinating properties of circles, triangles, quadrilaterals, and conics are developed.

Until the first edition of this book appearing in 2006, it has been almost impossible to obtain a complete collection of the problems proposed at the IMO in book form. "The IMO Compendium" is the result of a collaboration between four former IMO participants from Yugoslavia, now Serbia and Montenegro, to rescue these problems from old and scattered manuscripts, and produce the ultimate source of IMO practice problems. This book attempts to gather all the problems and solutions appearing on the IMO through 2009. This second edition contains 143 new problems, picking up where the 1959-2004 edition has left off.

How has the end of apartheid affected the experiences of South African children and adolescents? This pioneering study provides a compelling account of the realities of everyday life for the first generation of children and adolescents growing up in a democratic South Africa. The authors examine the lives of young people across historically divided communities at home, in the neighbourhoods where they live, and at school. The picture that emerges is one of both diversity and similarity as young people navigate their way through a complex landscape that is unevenly 'post'-apartheid. Historically and culturally rooted, their identities are forged in response to their perceptions of social redress and to anxieties about 'others' living on the margins of their daily lives. Although society has changed in profound ways, many features of the apartheid era persist: material inequalities and poverty continue to shape everyday life; race and class continue to define neighbourhoods, and 'integration' is a sought-after but limited experience for the young.

Spengler's work describes how we have entered into a centuries-long "world-historical" phase comparable to late antiquity, and his controversial ideas spark debate over the meaning of historiography.
