His other books include The Chronology of Ancient Nations, the Masudic Cannon, Book of Instructions, and more than 100 others, some of which are lost. He died on December 13, 1048, aged 75. He is buried in Ghaznah. The Book of Instruction in the Elements of the Art of Astrology was written for Lady Rayhanah, to whom it is dedicated. R. Ramsay Wright, the translator, said it could be regarded as a primer of 11th century science. Among its highlights are a comprehensive list of more than 150 Lots, various forms of aspects and planetary relationships, planetary positions relative to the sun, an excellent text on rulerships as well as comprehensive notes on weather and meteorological phenomena. This book was unknown to medieval European astrologers. This edition, comprising the astrological part of the original (sections 347-530) has been taken from Wright's pioneering 1934 translation, itself taken from Persian and Arabic sources. For this edition, text and tables have been reset, and a new index added.

remains of the Empire-the terraces, palaces, reliefs, paintings, and enameled bricks of Pasargadae, Persepolis, and Susa; the impressive royal tombs of Nagsh-i Rustam; the monumental statue of Darius the Great-serve to remind visitors of the power and unprecedented luxury of the Great Kings and their loyal courtiers (the "Faithful Ones"). Though long eclipsed and overshadowed by the towering prestige of the "ancient Orient" and "eternal Greece," Achaemenid history has emerged into fresh light during the last two decades. Freed from the tattered rags of "Oriental decadence" and "Asiatic stagnation," research has also benefited from a continually growing number of discoveries that have provided important new evidence-including texts, as well as archaeological, numismatic, and iconographic artifacts. The evidence that this book assembles is voluminous and diverse: the citations of ancient documents and of the archaeological evidence permit the reader to follow the author in his role as a historian who, across space and time, attempts to understand how such an Empire emerged, developed, and faded. Though firmly grounded in the evidence, the author's discussions do not avoid persistent questions and regularly engages divergent interpretations and alternative hypotheses. This book is without precedent or equivalent, and also offers an exhaustive bibliography and thorough indexes. The French publication of this magisterial work in 1996 was acclaimed in newspapers and literary journals. Now Histoire de l'Empire Perse: De Cyrus a Alexandre is translated in its entirety in a revised edition, with the author himself reviewing the translation, correcting the original edition, and adding new documentation. Pierre Briant, Chaire Histoire et civilisation du monde achémenide et de l'empire d'Alexandre, Collège de France, is a specialist in the history of the Near East during the era of the Persian Empire and the conquests of Alexander. He is the author of numerous books. Peter T. Daniels, the translator, is an independent scholar, editor, and translator who studied at Cornell University and the University of Chicago. He lives and works in New York City.

This book deals with the early development of ?aivism in ancient Dak?i?a Kosala, the region that roughly corresponds to the modern state of Chhattisgarh, plus the districts of Sambalpur, Balangir and Kalahandi of Odhisha (formerly Orissa). At the end of the sixth and the beginning of the seventh century, this region was under the control of the P???ava king ?ivagupta alias 'B?l?rjuna' hailing from ?r?pura (the modern village of Sirpur), who was a great patron of religion. Epigraphical evidence, supported by archaeological remains, has shown that by the time of ?ivagupta's reign, which lasted for at least fifty-seven years, Dak?i?a Kosala was already a rich center of early ?aivism. In the context of this setting the following research questions were formulated: what circumstances fostered the rise and development of ?aivism in this area, and did the Skandapur??a, an important and contemporaneous religious scripture, play any role in that development? An answer to these questions would not only shed light on the religious processes at work in Dak?i?a Kosala, but would also touch upon the interplay of political, social, economic and geographical factors.

The dietary prohibitions in Leviticus 11 and Deuteronomy 14 represent one of the most detailed textual overlaps in the Pentateuch between the Priestly material and Deuteronomy, yet study of them is often stymied by the rare terminology. This is especially the case for the birds: their identities are shrouded in mystery and the reasons for their prohibition debated. Peter Altmann attempts to break this impasse by setting these flyers within the broader context of birds and flying creatures in the Ancient Near East. His investigation considers the zooarcheological data on birds in the ancient Levant, iconographic and textual material on mundane and mythic flyers from Egypt and Mesopotamia, as well as studying the symbolic functions of birds within the texts of the Hebrew Bible itself. Within this context, he undertakes thorough terminological studies of the expressions for the types of birds, concluding with possible reasons for their exclusion from the prescribed diet and the proposed composition-critical location for the texts in their contexts.
