Even in the terrible market downturn of 2000, when the Nasdaq lost 39 percent of its value and stocks like Lucent and Cisco saw their share price drop by 80 percent or more, a number of investment sectors actually gained in value. The Dow Jones index, minus its technology stocks, broke even. In other words, even in the worst markets, not every stock or sector goes down. Through what he calls the nine essential laws of successful investing in a volatile market, Carlson reveals: · How to diversify the portfolios across stock sectors and investment vehicles · The critical importance of matching one's investment style — value, growth, buy and hold — to the kinds of stocks one invests in · The importance of “easy hold” — no-brainer stocks — in a portfolio, stocks that will grow 10 to 12 percent a year with minimal volatility. The Online Circulation of Audiovisual Content from the Small Market Perspective

Advisor of Leadership at Google and former vice president of leadership at LinkedIn claims that the biggest driver of motivation is the chance to serve a larger purpose beyond our careers and ourselves, rather than salary, benefits, bonuses, or other material incentives; companies that are able to successfully focus their people, their teams, and their culture around meaning outperform their competition. Fred Kofman's approach to leadership has little to do with the standard practices taught in business school and traditional books. Bringing together economics and business theory, communications and conflict resolution, family communication and mindfulness meditation, Kofman argues in The Meaning Revolution that our most deep-seated, unspoken, and universal anxiety stems from our fear that our life is being wasted--that the end of life will overtake us when our song is still unsung. Material incentives--salary and benefits--account for perhaps 15 percent of employees' motivation at work. The other 85 percent is driven by a need to belong, a feeling that what we do day in and day out makes a difference, that how we spend our time on earth serves a larger purpose beyond just ourselves. Kofman claims that transcendental leaders, wherever they are in the hierarchy, are able to put aside their self-interests and help others to feel connected with others on a team or in an organization on a great mission and part of an ennobling purpose. He argues that every organization involved in work that is nonviolent and non additive has what he calls an "immortality project" at its core. And the challenge for leaders is to identify and expand on that core, to inspire all stakeholders to take part.

Solitons in Action is a collection of papers that discusses the concept of a wave packer or pulse known as a soliton. One paper reviews the development of the solitary wave concept, with emphasis on the difference between a solitary wave and a soliton. The Korteweg-deVries (KdV) equation shows the interactions between infinite sets of conservation laws and the inverse scattering transform method. The Backlund transform technique produces hierarchies of multisoliton solutions for nonlinear wave equations. The Gel'fand-Levitan algorithm can effect an inverse scattering calculation that relates changes in the scattering data to changes in the solution of corresponding wave equation. One paper points out that concepts in differential geometry can show the fundamental nature of soliton behavior and the relationship between inverse scattering and the Backlund transformation. Solitons in action can be viewed as magnetic flux propagates through a gap (between two closely-spaced superconductors) in quantum units. This view results in a simplified procedure for perturbation expansions around multisoliton solutions. This collection can prove useful for researchers involved in the study of fluid mechanics, of pure and applied sciences, of mathematical sciences, and of wave theory.
